The cat owner warrants that the cat(s) do not have, and have not been exposed to any communicable disease within a thirty (30) day period prior to boarding at the Cottage Retreat, and have had all vaccinations (FVRCP mandatory) for proper health care, and are flea free. Flea control (Advantage) will be applied, at owner's expense, if fleas are present.

The cat owner agrees to these conditions for subsequent visits.

## A Spoiled Cat Cottage Retreat – Accommodations Agreement

This is a Contract between A Spoiled Cat Cottage Retreat (hereinafter called "SCCR") and the pet(s) caregiver whose signature appears below (hereinafter called "Owner") valid for one calendar year,

1. Owner authorizes and consents to SCCR providing accommodations to and care of pet(s) listed below.
2. Owner agrees to pay the rate for accommodations for the duration of the pet's stay at SCCR. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet(s) during the period that said pet(s) is in the care of SCCR. Owner further agrees that the pet(s) shall not leave SCCR until all charges are paid to SCCR by Owner.
3. By Signing this Contract and leaving Pet(s) with SCCR, Owner certifies to the accuracy of all information given about said pet(s).
4. SCCR shall exercise reasonable care for the pet(s) delivered by the Owner to SCCR. The owner further agrees to be solely responsible for any and all acts or behaviour of said pet(s) while in the care of SCCR.
5. Owner specifically represents that he or she is the sole owner of the pet(s), free and clear of all liens and encumbrances.
6. **Owner certifies that pet(s) is free of fleas, parasites and any other transmittable viral or contagious conditions.** Should fleas, parasites or any other transmittable or contagious conditions be found with said pet(s) during pet's stay, Owner agrees to pay for the appropriate flea treatment of said pet(s). Owner permits pet(s) to be isolated from other cats until fleas and fleas dirt is gone or any other contagious or transmittable condition is no longer contagious.
7. All outdoor cats and those living with dogs must be on a veterinary recommended fleas tx. SCCR is not responsible should indoor or outdoor pets contract fleas if on tx or not.
8. The Owner acknowledges that SCCR is not responsible and hereby releases SCCR if any liability for any loss or injury to pet and/or items brought with pet(s) wheresoever or howsoever arising including without limiting the generality of the foregoing loss or injury arising from fire, illness, theft, ingestion of foreign body, contracting contagious conditions or fleas from another pet(s), or loss arising from accidental escapes. Owner agrees to be responsible for any costs incurred as a result of the above.
9. Owner agrees to allow pet(s) to be moved to an alternative suite within SCCR if necessary.
10. All charges incurred by Owner shall be payable upon pick-up of pet(s). Owner agrees to pay half of total charges for pet(s) expected to be in the care of SCCR for two weeks or longer and the balance due upon pickup.
11. Owner agrees to pick up pet(s) at the scheduled pick up date or alternative date as arranged between Owner and SCCR. If Owner does not pick up pet(s) and does not respond within ten days written notice given by SCCR to Owner, SCCR may treat pet(s) as abandoned. Owner is responsible for all costs incurred.
12. If pet(s) become ill or if the state of the Pet's health otherwise requires profession attention, SCCR, in it's sole discretion, may engage in the services of a veterinarian or administer medications, or give other requisite attention to the pet(s), and the expenses thereof shall be paid by Owner. SCCR will attempt to consult with said emergency contact person and/or Owner, should SCCR feel it necessary to do so. Owner agrees to reimburse SCCR directly for all veterinarian charges and any medical, drug and/or other expenses incurred regarding pet(s).
13. This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and SCCR.
